Intergovernmental Conference to Adopt the Global Compact for Safe, Orderly and Regular Migration



## 10-11 December 2018, Marrakesh, Morocco

This Intergovernmental Conference is convened under the auspices of the General Assembly of the United Nations and held pursuant to resolution 71/1 of 19 September 2016, entitled "New York Declaration for Refugees and Migrants", which decided to launch a process of intergovernmental negotiations leading to the adoption of a global compact for safe, orderly and regular migration. The modalities for the Conference were further elaborated in resolutions 71/280 of 6 April 2017 and 72/244 of 24 December 2017.

**SECRETARY-GENERAL OF THE CONFERENCE**: Ms. Louise Arbour, UN Special Representative for International Migration, Secretariat of the United Nations, New York

**LEVEL OF PARTICIPATION:** The Intergovernmental Conference will be held at the highest political level, including Heads of State or Government.

**OUTCOME**: The adoption of an intergovernmentally negotiated and agreed outcome, entitled "Global Compact for Safe, Orderly and Regular Migration", for which the negotiations shall be concluded by July 2018, in accordance with its resolution 71/244.
